## Criteria and requirements of RMA:

## 1. General Requirements:

- 1.1 FYC is HK\$650,000 (Based on 2012 Production)
- 1.2 Only First Year Commission paid in 2012 is counted and it comprises of:
  - FYC for Individual Life Business
  - FYC for Employees Benefits including Mandatory Provident Fund
  - Commission for General Business
  - Annual premium annuities, single premium annuities
- 1.3 Only FYC paid to the applicants and agents direct supervised by the applicants will be counted
- 1.4 The Applicant must be a 2012 and 2013 GAMAHK authorized Active Member
- 1.5 The applicant must be a field management person who directly manages people and activities that generate sales
- 1.6 The Applicant who has become manager or company contract manager in the recent three years (i.e. period will be counted from 1 January 2010 to 31 December 2012)
- 1.7 The applicant must directly supervised at least 3 representatives under his/her supervision as at 31st December 2012
- 1.8 Applicant can only entitle "Rookie Manager Award" one time in life time

## 2. Special Requirements:

- 2.1 In case of disagreements (about commissions or agent supervision), an applicant's home office shall provide the final decision
- 2.2 The home office of the applicant's company must certify all applications
- 2.3 The administration fee of HK\$400 must accompany the application
- 2.4 The Applicant must meet all general requirements

- 1.3 Comparing to 2011, a growth at 50 99.9% in 2012 FYC to award BGA (Silver); or a growth at 100% or above to award BGA (Gold)
- 1.4 The applicant must work under the registered company for more than 36 months or worked for only one company
- 1.5 The applicant must be a 2012 and 2013 GAMAHK authorized Active Member
- 1.6 The applicant must be a field management person who directly manages people and activities that generate sales
- 1.7 The applicant must directly supervised at least 4 representatives under his/her supervision as at 31st December 2012

- 1.5 The applicant must directly supervised at least 6 representatives under his/her supervision as at 31st December 2012

#### 2. Special Requirements:

- 2.1 In case of disagreements (about commissions or agent supervision), an applicant's home office shall provide the final decision
- 2.2 The home office of the applicant's company must certify all applications

By applying for a GAMA International award, the applicant certifies that he or she meets all award criteria.

#### **Applicant Position**

Applicants must be a nonsalaried, commissioned field leader who manages people and activities that generate sales. Applicants for the Frontline Leader Award and the International Management Award must base their applications solely on business produced by their agency or firm while they were in active direction of that agency or firm.

#### **Application Completion and Submission**

All applications must be complete and legible. Please type or carefully print your applications so that we can process them efficiently and correctly. Also, please remember to complete all commission information and total all calculations. We will review your totaled calculations, but we cannot be responsible for incomplete submissions.

#### **Commission Eligibility**

Commissions in excess of 70 percent of premium are not allowed in fulfillment of the minimum requirement.

#### **Commission Eligibility Disputes**

In cases of disagreement about commissions or agent supervision, an applicant's home office shall make the final decision.

#### **General Rules and Requirements**

#### **Commissions From Multiple Companies**

Commissions from more than one company may be submitted to fulfill the minimum requirement. Each company must certify the specific amounts of business attributed to it. It is the applicant's responsibility to ensure that the total amount of business submitted equals or exceeds the minimum award requirements. Please make copies of the application for each company to complete. Total all commissions and enter that information on the original application. Attach additional information and certification to the original and submit. Applications without all of the information totaled on one sheet will be considered incomplete

#### **Filing Fees**

All applications must be accompanied by check payment. We cannot match applications with payments submitted separately. If membership dues and application fees have not been paid, award qualifiers will not be certified, listed in the *GAMA International Journal* or recognized at LAMP.

#### **GAMA Membership**

The Applicant(s) must be a 2012 and 2013 of GAMAHK Active members in good standing. Applicants who are applying for the MAA, IMA Diamond, or IMA Platinum must have paid the full US\$300 membership fees prior to applying for the award.

#### **Home Office Certification**

The home office of the applicant's company or companies must certify all applications.

#### **Notification of Award**

All certified qualifiers will be notified in July 2013. Depending on your company's arrangement with GAMA International, you will receive your qualifying certificate either directly from GAMA International or you're your awards certifier. Please clarify this with your company before you submit your application so you will know when to expect your qualifying certificate.

#### **Product Eligibility**

The minimum requirements for all commission-based awards must be fulfilled by commissions paid during the 2012 calendar year on the following types of business:

- Unlimited Credit: Life insurance, annuities, disability income, pensions, accidental death and dismemberment, long-term care, critical illness and endowments
- Limited Credit: Health insurance, pensions from nonlife insurance companies, mutual funds, securities, wrap accounts / asset management accounts and planning fees
- Property and casualty insurance

#### **Frequently Asked Questions**

#### What are the filing fees?

The following filing fees are required with your application:

- Master Agency Award (MAA)— HK\$2,765
- International Management Award (IMA)— HK\$1,385
   (if you qualify for the Master Agency Award, you are automatically entered for the IMA Diamond and do not need to submit an IMA application or filing fee)
- Frontline Leader Award (FLA)— HK\$910

How does GAMA International establish its criteria for the Frontline Leader Award and the International Management Award in the categories of ordinary/ traditional and financial planning? GAMA International follows the guidelines established by the Million Dollar Round Table (MDRT) in determining eligible production credits.

# For the International Management Award, how do I handle a gemini agency or firm or co-general agent/ manager situation?

In cases of gemini agencies or co-general agent/manager situations, field office heads may apply jointly if they do not have double the minimum IMA production credits required to file separately for a certain level. When applications are made jointly, one joint award is presented to the applicants.

Scenario 1 — Smith and Jones have US\$1,800,000 in production credits and want to file for the International Management Award – Platinum. Since they do not have enough production credits to file separately at this level, they opt to file one joint application for the IMA Platinum. (If they filed separately, they would file using US\$900,000 for each of them and receive the IMA Silver.) The award is issued to Smith and Jones. They pay HK\$1,385 + HK\$400 for the extra applicant, for a total application fee of HK\$1,785.

If field office heads do have double the minimum IMA production credits required for a certain level, they may opt to file separate applications. In these cases, each applicant is issued his or her own award.

Scenario 2 — Smith and Jones have US\$3,600,000 in production credits and prefer to get individual awards. Rather than applying for one joint International Management Award – Diamond as in scenario 1, they opt to file two separate applications for the International Management Award – Platinum. Each person, Smith and Jones, receives his or her own award. Since they opted to apply for two awards, they would pay HK\$1,385 each, for a total application fee of HK\$2,770.

# If I qualify for the Master Agency Award, must I separately apply for the International Management Award?

No. All Master Agency Award qualifiers are automatically certified for the International Management Award and will receive recognition for both awards. You only need to apply for the Master Agency Award.

#### Can I apply for both the FLA and the IMA?

Yes, you may apply for both awards if you meet the criteria for both awards. This requires that you manage at least eight full-time agents, as well as meet minimum commission levels for both awards. To receive both awards, you must apply for each award individually and pay the fee for each award.
