GAMA Introduction GAMA 簡介

GAMA 美國總會成立於 1951 年,於世界各主要城市總共認可了 130 個當地協會,會員超過一萬人,規模龐大。總會主要服務範圍包括為會員開辦多方面的專業管理訓練課程,提供有關的資料及定期舉辦大型業內會議,邀請世界各地的傑出代表進行演說,與會員分享及交流培訓和管理上的心得。

香港人壽保險經理協會(英文簡稱 GAMAHK)於 1994年自美國引入香港,是目前香港唯一人壽保險經理協會。

本會成立宗旨是借著訓練課程及工作坊,提升經理們的管理技巧,包括在增員、培訓、督導及激勵各方面。而協會每年都會舉辦研討會,邀請業界及行外有建樹的精英分享心得,交流經驗,籍此把不同公司的文化連成一線,提升保險業的專業地位。

協會訂有多項國際性榮譽獎項,以表揚壽險業內有傑出管理成就的經理,而得獎者必須為 GAMAHK 的會員。每年均有眾多會員獲獎,反映香港壽險經理的管理質素正不斷提升。

Home Office Certification

The home office of the applicant's company or companies must certify all applications.

If a current or former home office would not certify an applicant's commissions/premiums within thirty (30) days of the applicant's submission, the applicant may provide alternative documentation to support their qualifying commissions/premiums. GAMA International will recognize this as a non-formal certification, and will issue the applicant with the applicable award once supporting documents are submitted and payment is made.

Notification of Award

All certified qualifiers will be notified in July 2017. Depending on your company's arrangement with GAMA International, you will receive your qualifying certificate either directly from GAMA International or your awards certifier. What are the filing fees?

The following filing fees are required with your application:

- Master Agency Award (MAA)— HK\$3,120
 (By qualifying for the MAA, applicants are automatically certified for the IMA at one level, and no further IMA application form and filing fee are needed.)
 - (MAA awardees 2017 are entitled to the Hall of Honor if they have awarded MAA for 20 years or above as at 31 December 2016. No further application form and filing fee are needed.)
- International Management Award (IMA) HK\$1,560
- Frontline Leader Award (FLA)— HK\$1,014

How does GAMA International establish its criteria for the Frontline Leader Award and the International Management Award in the categories of ordinary/ traditional and financial planning? GAMA International follows the guidelines established by the Million Dollar Round Table (MDRT) in determining eligible production credits.

If I qualify for the Master Agency Award, must I separately apply for the International Management Award?

No. All Master Agency Award qualifiers are automatically certified for the International Management Award and will receive recognition for both awards. You only need to apply for the Master Agency Award.

Can I apply for both the FLA and the IMA?

Yes, you may apply for both awards if you meet the criteria for both awards. This requires that you manage at least eight full-time agents, as well as meet minimum commission levels for both awards. To receive both awards, you must apply for each award individually and pay the fee for each award.
