(鑽石獎)最少聘請代理人10位或以上

- 申請人之新聘請代理人必須為直接管轄代理人
- 新聘請之代理人必須為非業界招募

2. 管理發展獎 (FLA)

- 申請人必須符合所有基本資格的要求

3. 管理卓越獎 (IMA)

- 申請人必須符合所有基本資格的要求
- 首年佣金是包括申請人本人及其直接及間接管轄之代理人的首年佣金
- 於 2024 年 12 月 31 日,申請人最少直接管理 8 名代理人

4. 最高管理成就獎 (MAA)

- 申請人必須符合所有基本資格的要求
- 申請表格必須附上團隊生產紀錄及公司核實方為有效 · 另申請人的直接管轄代理人和 間接管轄代理人的生意額都計算在內
- 所有取得最高管理成就獎資格者均可自動合資格成為管理卓越獎項之得獎者,而毋須 再付任何額外行政費用

5. Hall of Honor (HOH)

- 榮譽得獎者必須符合所有基本資格的要求,並需要申請成為 2024 年最高管理成就獎 得獎者
- 經 GAMA 美國總會認可授權頒發之最高榮譽獎項·以嘉許及認可截至 2024 年 12 月 31 日曾榮獲 20 年或以上之最高管理成就獎的業界精英領袖
- 得獎者毋須再付任何附加之行政費用

General Rules and Requirements:

- 1. Applicant should register with GAMAHK as International Member in good standing for the ensuring year.
- 2. Only First Year Commission (FYC) paid in 2024 is counted and it comprises of:
 - FYC for Individual Life Business
 - FYC for Employees Benefits including Mandatory Provident Fund
 - Commission for General Business
 - Annual premium annuities, single premium annuities.
- 3. The applicant must be a field management person who directly manages people and activities that generate sales.
- 4. In case of disagreements (about commissions or agent supervision), an applicant's home office shall provide the final decision.
- 5. The home office of the applicant's company must certify all applications.
- 6. The filing fee must be paid and submit along with the application form (Form A1).
- 7. <u>Application deadlines</u>: 14th March 2025 for qualification to recognize at GAMA Awards Presentation 2025 & special recognition at Awards edition of GAMA Global E-Journal & GAMAHK Souvenir booklet and newspaper supplement.



Special requirements of each award:

1. Excellence Recruitment Award (ERA) (2023 NEW Award)

Applicants must meet all general requirements.

- In the qualifying period of 1st January − 31st December 2024, applicant should have 4 active new recruits to award ERA (Gold); or 6 active new recruits to award ERA (Platinum); or 10 active new recruits to award ERA (Diamond).
- Only count the new recruits under the direct agency of the applicant.

Only count non-industrial new recruits.

• Active new recruits must be in-force as at 31st December 2024.

2. Frontline Leader Award (FLA)

Applicants must meet all general requirements.

- Only FYC paid to the applicants and agents direct supervised by the applicants will be counted.
- Personally supervise at least 5 full-time career agents under direct team/supervision as at 31st December 2024.

3. International Management Award (IMA)

Applicants must meet all general requirements.

- Only FYC paid to the applicants and his/her direct and indirect reports will be counted.
- Personally supervise at least 8 full-time career agents under direct agency as at 31st December 2024.

4. Master Agency Award (MAA)

Applicants must meet all general requirements.

- Only applications from a main or central office representing an entire agency/firm will be accepted. FYC paid to the agents direct or indirect supervised by the applicants will be counted.
- By qualifying for the MAA, applicants are automatically certified for the <u>IMA at one level</u>, and no further IMA application form and filing fee are needed.

5. Hall of Honor

- Awardees must meet all general requirements and shall be the awardee of MAA in 2025.
- It is the highest honor given by the GAMA Global to recognize an industry leader who has been awarded MAA for 20 years or above as at 31st December 2024.
- No further application form and filing fee are needed.
