申請 GAMA 國際榮譽獎項的基本資格

- ❖ 為申請年度 GAMAHK 國際會員，並享有良好信譽；
- ❖ 業績年度的首年佣金計算，當中包括：
 - 個人壽險的首年佣金；
 - 僱員福利計劃的首年佣金，包括強積金計劃；
 - 一般保險計劃的佣金；
 - 年繳或一次清繳的年金計劃。
- ❖ 從事銷售管理的工作，並直接管轄有關從事銷售工作之代理人；
- ❖ 過去 3 年內須於操守方面無任何業界違規記錄（包括「保險業監管局 (IA)」及「強制性公積金計劃管理局 (MPFA)」）；
- ❖ 所屬公司必須審核所有的申請文件，如有任何爭議（包括佣金計算或管轄之代理人），申請人之公司應提供最後的決定；
- ❖ 申請表格 (Form A1) 必須連同行政費提交至 GAMAHK 辦事處。

GAMA 國際榮譽獎項特別準則

❖ 最佳造星獎 (ERA)

- 申請人必須符合所有基本資格的要求；
- 申請人需於業績年度內，達到以下招募人數最低要求：
 - (金獎) 4 位保險代理人；
 - (白金獎) 6 位保險代理人；
 - (鑽石獎) 10 位保險代理人。
- 申請人之新招募代理人必須為直接管轄代理人；
- 新招募之代理人必須為非業界招募；
- 新招募之代理人必須於 2026 年 12 月 31 日仍然為有效的合約從業員。

❖ 管理發展獎 (FLA)

- 申請人必須符合所有基本資格的要求；
- 首年佣金是包括申請人本人及其直接管轄之代理人的首年佣金；
- 於 2026 年 12 月 31 日，申請人最少直接管轄 5 名代理人。

❖ 管理卓越獎 (IMA)

- 申請人必須符合所有基本資格的要求；
- 首年佣金是包括申請人本人及其直接及間接管轄之代理人的首年佣金；
- 於 2026 年 12 月 31 日，申請人最少直接管轄 8 名代理人。

❖ 最高管理成就獎 (MAA)

- 申請人必須符合所有基本資格的要求；
- 首年佣金是包括申請人本人及其直接及間接管轄之代理人的首年佣金；
- 所有取得最高管理成就獎資格者均可自動合資格成為管理卓越獎項之得獎者，而毋須再付任何額外行政費用。

❖ Hall of Honor (HOH)

- 榮譽得獎者必須符合所有基本資格的要求，並需要申請成為當年最高管理成就獎得獎者；
- 經 GAMA 美國總會認可授權頒發之最高榮譽獎項，以嘉許及認可截至 2026 年 12 月 31 日曾榮獲 20 年或以上之最高管理成就獎的業界精英領袖；
- 得獎者毋須再付任何附加之行政費用。

General Rules and Requirements for Applying for the GAMA Global Awards

- ❖ Register with GAMAHK as an International Member in good standing for the applying year;
- ❖ Only First Year Commission (FYC) paid in Production year is counted and it comprises of:
 - FYC for Individual Life Business;
 - FYC for Employees Benefits including Mandatory Provident Fund;
 - Commission for General Business;
 - Annual premium annuities, single premium annuities.
- ❖ Serve as a field management professional responsible for directly managing people and activities that generate sales;
- ❖ No any record of conduct violations of the industry within the preceding three years, (including Insurance Authority (IA) and Mandatory Provident Fund Schemes Authority (MPFA));
- ❖ All applications must be certified by the applicant's company home office. In the event of any disputes, including those concerning commissions or agent supervision, the applicant's home office shall render the final decision;
- ❖ The filing fee must be paid and submit along with the application form (Form A1).

Special Requirement for the GAMA Global Awards

❖ Excellence Recruitment Award (ERA)

- Applicants must meet all general requirements;
- In the Production year, applicant should fulfill the specified recruitment as below,
(Gold) – at least 4 active new recruits; or
(Platinum) – at least 6 active new recruits; or
(Diamond) – at least 10 active new recruits.
- Only count the new recruits under the direct agency of the applicant;
- Only count non-industrial new recruits;
- Active new recruits must be in-force as of 31st December 2026.

❖ Frontline Leader Award (FLA)

- Applicants must meet all general requirements;
- Only FYC paid to the applicants and agents direct supervised by the applicants will be counted;
- Personally supervise at least 5 full-time career agents under direct team/supervision as of 31st December 2026.

❖ International Management Award (IMA)

- Applicants must meet all general requirements;
- FYC paid to the applicants and his/her direct and indirect reports will be counted;
- Personally supervise at least 8 full-time career agents under direct agency as of 31st December 2026.

❖ Master Agency Award (MAA)

- Applicants must meet all general requirements;
- FYC paid to the agents direct or indirect supervised by the applicants will be counted;
- By qualifying for the MAA, applicants are automatically certified for the IMA at one level, and no further IMA application form and filing fee are needed.

❖ Hall of Honor (HOH)

- Awardees must meet all general requirements and shall be the awardee of MAA in awarding year;
- It is the highest honor given by the GAMA Global to recognize an industry leader who has been awarded MAA for 20 years or above as of 31st December 2026;
- No further application form and filing fee are needed.

- ❖ The Chinese version is provided for reference only; in case of any discrepancy, the English version shall prevail.
